## DISCLAIMER, TERMS & CONDITIONS

Please note that all persons using hire item "Hot Tub" & Accessories (Equipment) from us do so at their own risk. The person/s or organisation hiring this equipment will be responsible / liable for any damage or injury occurring from or as a result of misuse or reckless use. These guidelines are for the safety of all people using this equipment, and is the sole responsibility of the hirer to ensure they are fully complied with at all times. Wight Hot Tub Hire cannot except any responsibility for any injury caused to anyone using this equipment. All individuals using the equipment must fully comply with the terms and conditions of hire. If this is not the case, individuals will be responsible for any damage to the equipment, property of the hirer or injury. I have read the above agreement and fully understand and accept the conditions as above. I am aware that whilst in my care I am fully responsible for the hire item and will pay for any loss or damage in full that may occur (retail price), this will include the hire item being returned in an unacceptable condition.

## HIRE AGREEMENT INCLUDING TERMS AND CONDITIONS OF HIRE

This is the responsibility of the person who is hiring the Hot Tub to ensure that possible steps are taken to avoid injury or damage to the Hot Tub. Please ensure that following Safety Instructions are followed at all times.

1. The Hirer will provide adequate delivery and collection access. It is the responsibility of the Hirer to ensure that the suitable access is available to get the goods into the property/garden. No refund will be given by Wight Hot Tub Hire in the event that, on the day of delivery, our engineers cannot get the equipment into the desired location. The Hirer will also ensure that a suitable 240V 13amp supply is available within 12 metres of the spas desired location. Wight Hot Tub Hire is NOT responsible or liable for the electricity/power used by the goods during the period of hire.
2. For safe and correct operation the surface for the Hot Tub should be a flat/solid non grassed area. Either patio, concrete or decking. PLEASE NOTE:- Decking areas are used at your own risk as the weight can be up to 1600 kilos (fully occupied).
3. This Hot Tub is for 4 to 6 people to use at any one time. Overloading the spa can cause damage for which you will be liable. Hot Tub users must be over 6 years of age and accompanied by adults at all times.
4. No food, drinks or chewing gum to be allowed on or near the Hot Tub. (Please note if the Hot Tub is collected in a dirty condition then the person hiring will incur a cleaning charge of £35.00) If any sand is found to be in the Hot Tub a charge of £45 is payable.
5. No smoking or barbecues near the Hot Tub.
6. Do not sit on the sides of the Hot Tub or on top of the hard top cover. Inflatable seats to be used solely for sitting on whilst in the Hot Tub. (these can also be used for children as a booster seat).
7. Testing and inspection of equipment, Wight Hot Tub Hire will comprehensively test all electrical equipment before commencement of hire. Equipment will be inspected and tested where appropriate in accordance with the relevant statutory requirements and if Equipment needs to be recovered from the Hirer for such purposes White Hot Tub Hire will substitute items of similar specification.
8. In the event that anything appears not to be working correctly, please remove all users from the Hot Tub.
9. Please try to keep the Hot Tub as clean as possible. Wiping feet before entering the Hot Tub will maintain the cleanliness.
10. Equipment defects should be reported to Wight Hot Tub Hire as soon as possible. Please do not attempt to repair any part of the hired item.
11. Upon booking a £50 deposit will be required. This can be paid by Cash, Cheque or Bank Transfer. If a cancellation occurs this is none refundable unless an alternative date is booked (within 3 months)
12. The outstanding balance is to be paid in CASH on delivery to the engineer.
13. Security Deposit of £150 CASH / CHEQUE is payable upon delivery of the Hot Tub. This is fully refundable as long as all the terms and conditions have been met by the hirer. £150 cash / Cheque will be returned by the engineer on collection of Hot Tub.
14. Any monies outstanding on demand (interest on amounts overdue is at Santander Bank base rate plus 4%) and will be liable for legal charges incurred by Wight Hot Tub Hire in the recovery of amounts due.
15. The HIRER must be at the property on the day of collection please ensure that the Hot Tub is still plugged into the power and running as normal for our engineer to inspect it upon collection. The engineer must be able to test the temperature of the water and the functionality of the Tub. If the Tub has been unplugged or if the water has been emptied we reserve the right to retain your deposit until the Hot Tub has been fully tested and proven to be problem free. Wight Hot Tub Hire will drain and dismantle the Tub after inspection has taken place.
16. Excess Hire Charges will be charged at a rate of £50 per day for every additional day or part day that the goods are kept by the Hirer over the agreed hired period unless this delay is caused or agreed by Wight Hot Tub Hire.
17. Ownership of equipment and goods, equipment hired remains the property of Wight Hot Tub Hire at all times.
18. Wight Hot Tub Hire will not be responsible for any water damage that occurs from spas set up indoors/outdoors.
19. If you are pregnant or have a medical condition, please consult your doctor before using the Hot Tub.
20. Lost or stolen equipment will be charged to the Hirer at the FULL retail value.
